## **GENERAL AGREEMENT FOR ACADEMIC COOPERATION**

**between**

**STEFAN CEL MARE UNIVERSITY OF SUCEAVA, Romania**

**And**

**QAINAR ACADEMY, Republic of Kazakhstan**

**Stefan cel Mare University of Suceava**, 13, University Street, 720229, Suceava, Romania, represented by Professor Valentin Popa, Ph.D., Rector

and

**Qainar Academy**, 125/185, Baizakov str., 050026, Almaty, Republic of Kazakhstan, represented by Professor Aisulu Janegizova, Ph.D, Rector

Hereinafter jointly referred to as Parties, and individually – Party, establish this General Agreement to foster international cooperation in education and common research fields.

1. Both Parties agree to encourage the following activities, in particular, to promote international academic cooperation:
  - 1.1. Exchanging students, scientists and academic staff within the frame of Erasmus+ or/and individual agreements;
  - 1.2. Participation/organization of conferences and publication of scientific proceedings;
  - 1.3. Reviewing scientific publications, dissertation, and other research papers;
  - 1.4. Exchanging information about seminars and scientific conferences organized by both Parties;
  - 1.5. Applying and participating in joint research projects;
  - 1.6. Exchange of information and documentation, including the exchange of methodical recommendations, scientific publications and research results.
2. This General Agreement shall apply to educational and research organizations attached to each Party.
3. This Agreement constitutes the entire agreement between the Parties, and all prior discussions, arrangements, and understandings, whether verbal or in writing, are merged in this Agreement.
4. This Agreement is not considered a contract creating legal and financial relationships between the Parties. Instead, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/research relationship. The Parties will conclude other agreements as supplements

to the present Agreement specifying financial and juridical responsibilities to carry out concrete programs.

5. This General Agreement shall become effective as of the date of signatures of both Parties. The Agreement may be amended by the written consent of the Parties.

6. This Agreement signed by the two Parties will remain valid for five (5) years. At the end of the five-year term, the Agreement will be extended automatically for a further five (5) year period if no official request is otherwise taken into account.

7. This Agreement may be terminated by either Party with a minimum of 120 days written notice. The Parties understand that all activities in progress at the time of this Agreement termination shall be permitted to develop and end as planned unless otherwise agreed.

8. Each Party shall designate a person or office to serve as a liaison to implement this Agreement.
